Two or more charity trustees can be authorised to sign documents on behalf of the charity trustees of a charity by a resolution passed under s.333 of the Charities Act 2011 (2011 Act). This is referred to as a Section 333 Resolution.

Trustee resolutions. In order to assist us with the performance of our duties we will require the Trustees to sign certain resolutions: Interest resolution. This resolution determines the interest rate that we must charge owners who are in arrears with their levies. Without this resolution we are only entitled to charge interest on arrear levies in terms of the Prescribed Interest Rate Act.
